

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to AVCTrust.com and AVCTrust and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AVCTrust include AVCTrust.com and AVCTrust. The AVCTrust website is a Web Development site. By using the AVCTrust website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AVCTrust may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase AVCTrust's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through AVCTrust's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

AVCTrust collects and uses your personal information to operate its website(s) and deliver the services you have requested.

AVCTrust may also use your personally identifiable information to inform you of other products or services available from AVCTrust and its affiliates.

Sharing Information with Third Parties

AVCTrust does not sell, rent or lease its customer lists to third parties.

AVCTrust may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AVCTrust, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by AVCTrust. Use of Cookies
